1 SETTING INFORMATION

Vision and Values

Ark John Archer Primary Academy is an inclusive school where all students are made to feel welcome and valued. Our Academy vision sets out to ensure that all students enjoy high quality learning experiences through which they are able to achieve their full potential irrelevant of their needs. Our inclusive ethos aims to encourage all students to be actively involved in their own learning. This involves valuing all students and staff equally and reducing barriers to learning and participation. Ark John Archer Primary Academy aims to provide a rigorous and transformational education that prepares students for success at university and beyond.

Describe the Diverse Needs of the Community [e.g. school context from SEF]

Ark John Archer Primary Academy transitioned to the Ark Academy Network in September 2018. Our vision is Together As One which is underpinned by our values of Aspiration, Respect, Achievement, Community, Resilience and Kindness

The school is a mixed, non-selective, non-denominational primary school for children aged 4 – 11 years with classes from Reception to Year 6. There is a maximum class size of 30 pupils.

On its transition the school was a two-form entry school. As of September 2019, the school has been re-designated to a one-form entry primary school due a pan decreases in the number of children attending the school.

Ark John Archer Primary Academy is a vibrant and happy community school serving Wandsworth Local Authority. It is located just a few minutes' walk from Clapham Junction station and is in the Fairfield Ward. Many of our pupils come from the Winstanley Estate which is in the Latchmere Ward. This is an area of low-income housing, and the employment, health, crime and life expectancy statistics are evidence of clear levels of deprivation. There are 179 LSOAs (Lower-layer Super Output Areas which give indication of areas of deprivation) in Wandsworth. While none are in the 10% most deprived areas nationally there are 8 (4.5%) in the 20% most deprived. Four of these are in Latchmere Ward – the two most deprived neighbourhoods in Wandsworth are in Latchmere Ward. Of the 8 LSOAs in Latchmere Ward 7 (87.5%) are in the 40% most deprived in England.

The 2019 Index of Multiple Deprivation (IMD) placed areas of Latchmere Ward in the 10% most nationally deprived areas as opposed to other areas of the ward that are 50 – 60% least nationally deprived. Wandsworth is within the 50% least deprived Local Authorities (LAs) in England, where in 2015, it was amongst the 50% most deprived. The three LSOAs in the LA amongst the 10% most deprived in London were in Latchmere (2) and neighbouring Tooting (1) where we have many families in temporary accommodation. Our profile is as follows:

- Number on roll: 219
- 59% (130) of our children are in receipt of Pupil Premium funding.
- 56% (123) of the school population receive Free School Meals.
- 16% (35) of pupils have Special Educational Needs; 2% of these have EHC Plans (5 children)
- 41% of pupil's first language is not believed to be English.
- 49% of the school are Boys (106) and 51% are Girls (113)

The school was inspected by Ofsted in November 2017 under a Section 5 under its previous name of High View Primary School; The school's overall effectiveness was Requires Improvement. We believe we are a Good school that offers an education that will build knowledge and skills progressively that is taught through a values rich curriculum that will enrich the cultural capital and improve the life changes of our children.

Consultation to inform Audit/Action Plan: School staff, governors and support services

Consultation with stakeholders is an ongoing process, involving both formal and informal procedures. Regular reviews take place with support services to evaluate needs and provisions.

Views of Parents

Parental views are formally solicited at termly meetings. Parents are also encouraged to arrange to see staff if they have particular concerns (or complaints). Several members of staff are employed specifically because they speak community languages.

Views of Children and Young People

Pupils are regularly consulted, including through personal reviews and student voice polling.

2 PURPOSE

Ark John Archer Primary Academy is committed to providing a fully accessible environment which values and includes all pupils, staff, parents and visitors regardless of their education, physical, sensory, social, spiritual, emotional and cultural needs. We are committed to challenging negative attitudes about disability and accessibility and to developing a culture of awareness, tolerance and inclusion. We aim to as far as possible to remove those barriers which make it hard for a person who has difficulties with:

- Physical Co-ordination
- Mobility
- Continence
- Ability to lift, carry or move heavy objects
- Speech, hearing or vision
- Memory or ability to learn, concentrate or understand
- Perceiving risk of physical danger

All pupils should be able to take part in the day to day life our the school and benefit from the learning experiences we provide

Overall, the Accessibility Plan will contain relevant actions to:

- Improve access to the physical environment of the school, adding specialist facilities as necessary. This covers improvements to the physical environment of the school and physical aids to access education.
- Increase access to the curriculum for pupils with a disability, expanding the curriculum as necessary to ensure that pupils with a disability are as, equally, prepared for life as are the able-bodied pupils; (If the school fails to do this they are in breach of the Equality Act). This covers teaching and learning and the wider curriculum of the school such as participation in after-school clubs, leisure and cultural activities or school visits. It also covers the provision of specialist aids and equipment, which may assist these pupils in accessing the curriculum.
- Improve the delivery of written information to pupils, staff, parents and visitors with disabilities.

Examples might include hand-outs, timetables, textbooks and information about the school and school events. The information should be made available in various preferred formats within a reasonable time frame.

An Action Plan is attached in section 5 which relate to the three key aspects of accessibility. This plan will be reviewed and adjusted on an annual basis and or when appropriate. A new Accessibility Plan will be drawn up every three years.

We acknowledge that it is necessary to raise awareness of issues related to accessibility and to provide appropriate training for staff and governors in the matter of disability discrimination.

The main priorities in Ark John Archer Primary Academy's plan are as follows:

Increasing the extent to which disabled pupils can participate in the school curriculum

Ark John Archer Primary Academy will endeavour to provide suitable access to a range of curriculum opportunities.

- The school will endeavour to provide suitable access to a range of curriculum opportunities
- Where necessary, guidance and support will be given by the SENCO
- Ark John Archer Primary Academy have several Teaching Assistants who are deployed by the schools SENCO to ensure the needs of students with a statement or Education, Health and Care Plan are being met.
- Ark John Archer Primary Academy to facilitate services from a range of agencies for all pupils and their families.

Improving the physical environment of the school to increase the extent to which disabled pupils can take advantage of education and associated services

- Excellent access to the main building with automatic front doors
- There is a meeting room and toilets within easy reach of the reception so we can easily accommodate wheelchair users and visitors with reduced mobility.
- Sport facilities that are located on first and second floor are accessible by stair lifts. All buildings have ramps to enable access for wheelchair users.
- A lift is provided to access classrooms on the first and second floor for any students and school personnel with mobility needs.
- Ark John Archer Primary Academy does not currently have disabled toilet facilities and this has been identified as a priority for 2021/22 academic year.
